## **ABSTRACT**

*The background of this research is ineffectiveness Assistance Program Livable Small House in District Bagan Sinembah Rokan Hilir, Riau. The problem is connected with one of the variables that are assumed Policy Implementation can affect the effectiveness of Aid Program Livable Small House. In this study the researchers to formulate the problem: "How much influence on the implementation of the local government effectiveness program assistance of livable modest home in District Bagan Sinembah Rokan Hilir, Riau"*

*To analyze the problem of this study used the theory as a tool of analysis of Edward III (1980: 10), which consists of a Communication, Resources, Implementation and Structure Attitude Bureaucracy. As for the theory of effectiveness used the theory of Goggin et all in Soemaryadi (2005: 111-113), which consists Objectives / Result (result), procedural (compliance), monitoring (Monitoring) and Evaluation Based on the approach to these theories, the hypothesis is: "the magnitude of the effectiveness influence policy implementation assistance program of livable modest home in district Bagan Sinembah Rokan Hilir, Riau is determined by the dimensions of the implementation of the Communication, resources, implementation and Structure attitude Bureaucracy".*

*The method used in this research is an explanatory research while the source of data collection using literature study and field study with data collection using questionnaires, observation, and interviews. The sampling technique used was simple random sample. The data analysis technique used is the Simple Linear Regression*

*Based on the results of data processing is to be obtained research results that showed a positive and significant correlation between the effectiveness of the Policy Implementation Assistance Program Livable Small House in District Bagan Sinembah Rokan Hilir, Riau. Thus the hypothesis proposed in this study tested empirically.*
