

## **ABSTRACT**

*This research is based on "Policy Implementation on Development of Public Water Utilization, Agricultural Land and Cirata Reservoir Area".*

*Based on the background of the research, researchers formulate the following issues; Implementation of Policy on Development of Public Water Utilization, Agricultural Land and Cirata Reservoir Area as well as how the constraining factors and supporting factors in Policy Implementation About Development of Public Water Utilization, Agricultural Land and Cirata Reservoir Area.*

*In this study, the researchers tested the hypotheses based on the process and the methods of control proposed by George C. Edwards III. There are four influential variables in the implementation of public policy: Communication, and bureaucratic structure (1980: 10-12).*

*Based on the theories in the research framework, it can formulate the proposition of "Policy Implementation on Development of Public Water Utilization, Agricultural Land and Cirata Reservoir Area" can be run optimally through communication, resources, disposition and bureaucratic structure.*

*The research method used is qualitative research method. Sources and data collection techniques are primary and secondary data sources, while data collection is through the study of libraries and field studies through observation, interviews to informants and documentation.*

*Based on the result of research, show that in the implementation conducted by the Cirata Reservoir Management Board is in accordance with the working procedure in implementing the policy to pateanikeramba floating net and has been regulated by the policy of Governor Decree no. 41 of 2002 on the Development of Public Water Utilization, Agricultural Land and Cirata Reservoir Area.*

## ABSTRAK

Penelitian ini dilatarbelakangi oleh  
“Implementasi Kebijakan Tentang Pengembangan Pemanfaatan Perairan Umum,  
Lahan Pertanian dan Kawasan Waduk Cirata”.

Berdasarkan latar belakang penelitian tersebut,  
peneliti merumuskan masalah sebagai berikut; Implementasi Kebijakan Tentang Pengembangan Pemanfaatan Perairan Umum,  
Lahan Pertanian dan Kawasan Waduk Cirata serta bagaimana faktor penghambat dan faktor pendukung dalam Implementasi Kebijakan Tentang Pengembangan Pemanfaatan Perairan Umum, Lahan Pertanian dan Kawasan Waduk Cirata.

Dalam Penelitian ini peneliti menguji hipotesis berdasarkan proses dan cara-cara pengendalian yang di kemukakan oleh George C. Edwards III ada empat variabel yang berpengaruh dalam implementasi kebijakan publik yaitu: Komunikasi (*communications*), Sumber daya (*resources*), sikap (*disposition* atau *attituden*) dan struktur birokrasi (*bureucratic structure*) (1980:10-12).

Berdasarkan teori-teori dalam kerangka penelitian,  
dapat merumuskan proposisi “Implementasi Kebijakan Tentang Pengembangan Pemanfaatan Perairan Umum, Lahan Pertanian dan Kawasan Waduk Cirata” dapat berjalan optimal melalui komunikasi, sumber daya, disposisi dan struktur birokrasi.

Metode penelitian yang digunakan adalah metode penelitian kualitatif. Sumber dan teknik pengumpulan data adalah sumber data primer dan data sekunder, sedangkan pengumpulan data adalah melalui studi keperpustakaan dan studi lapangan yaitu melalui observasi, wawancara kepada informan dan dokumentasi.

Berdasarkan hasil penelitian, menunjukkan bahwa dalam implementasi yang dilakukan oleh Badan Pengelola Waduk Cirata sudah sesuai dengan prosedur kerjanya dalam mengimplementasikan kebijakan kepada petani keramba jaring apung dan telah di turunkan oleh kebijakan SK Gubernur No. 41 Tahun 2002 Tentang Pengembangan Pemanfaatan Perairan Umum, Lahan Pertanian dan Kawasan Waduk Cirata.
