

## **ABSTRACT**

*This research is motivated by the inadequate implementation of the Election Policy for Neighborhoods and Community Organizations in Cibadak Village, Astanaanyar District, Bandung City. Based on the background of the research, the researchers formulated the following problems: How to Implement the Policy for the Election of Neighborhood Associations and Citizenship in Cibadak Village, Astanaanyar District, Bandung City, Supporting and inhibiting factors in the Implementation of the Policy for the Election of Neighborhoods and Community Organizations in Cibadak Village, Astanaanyar District, Bandung , Efforts made in the Implementation of the Election Policy of Neighborhood Associations and Community Organizations in Cibadak Village, Astanaanyar District, Bandung City. The theoretical approach used in this research is the Policy Implementation theory with the dimensions: Organization, Interpretation, and Application. The research method used is descriptive with a qualitative approach, by collecting data through literature study, observation, in-depth interviews and documentation. The results showed that in implementing the election policy of Neighborhood Associations and Community Organizations in Cibadak Village, there were several obstacles. Among others: lack of understanding of human resources, lack of budget in the implementation of elections and lack of facilities and infrastructure. Efforts made to overcome obstacles in the implementation of the election policy Neighborhood Associations and Community Organizations in Cibadak Village include: Improving facilities and infrastructure in supporting the implementation of the election for the Head of Neighborhood Associations and Community Organizations and holding regular meetings / meetings to improve the functions of related organizations. with problems that become obstacles in the implementation of the Election Policy for Neighborhood Associations and Community Organizations..*

## **ABSTRAK**

Penelitian ini dilatarbelakangi oleh belum optimalnya Implementasi Kebijakan Pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak Kecamatan Astanaanyar Kota Bandung. Berdasarkan latar belakang penelitian, maka peneliti merumuskan masalah sebagai berikut: Bagaimana Bagaimana Implementasi Kebijakan Pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak Kecamatan Astanaanyar Kota Bandung, Faktor pendukung dan penghambat dalam Implementasi Kebijakan Pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak Kecamatan Astanaanyar Kota Bandung, Upaya yang dilakukan dalam Implementasi Kebijakan Pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak Kecamatan Astanaanyar Kota Bandung. Pendekatan teori yang dipakai dalam penelitian ini adalah teori Implementasi Kebijakan dengan dimensi : Organisasi, Interpretasi, dan Penerapan. Metode penelitian yang digunakan adalah deskriptif dengan pendekatan kualitatif, dengan mengumpulkan data melalui studi pustaka, observasi, wawancara mendalam serta dokumentasi. Hasil penelitian menunjukkan bahwa dalam implementasi kebijakan pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak, terdapat beberapa hambatan. Antara lain : kurangnya pemahaman sumberdaya manusia, kurangnya anggaran dalam pelaksanaan pemilihan dan kurangnya sarana dan prasarana. Upaya - upaya yang dilakukan untuk mengatasi hambatan-hambatan dalam implementasi kebijakan pemilihan Rukun Tetangga dan Rukun Warga di Kelurahan Cibadak antara lain : Peningkatan sarana dan prasarana dalam menunjang pelaksanaan pemilihan Ketua Rukun Tetangga dan Rukun Warga dan mengadakan Pertemuan/rapat rutin dalam peningkatan fungsi organisasi terkait dengan masalah yang menjadi hambatan di dalam Implementasi Kebijakan pemilihan Rukun Tetangga dan Rukun Warga.
